

PROWLER ON THE LOOSE....

The silence of the still early morning is suddenly interrupted by a loud frightening noise. Something has forcefully struck the house. The sound of running foot steps and rustling shrubs can be detected. The prowler is on the loose!

The prowler has been entering the back yards and gardens of residents in the vicinity of Urbano Drive and Corona Court. The "attack" usually occurs between 1:00 and 2:00 a.m.; but this time, November 8, 1984, it was 8:45 p.m. when three neighbors heard loud noises caused by objects that were thrust at their houses. In the past, the prowler has hurled rocks, bricks, and firewood logs, and also shot pellets at his victim's houses. He has broken and cracked windows as well as damage wood work, stucco, and roof tiles. Besides numerable costly repairs from his damage, residents have also reported lost sleep and time off from work to give access to repair people.

It is imperative that this prowler be apprehended. The police have asked us to advise you of this serious problem. If you have had a similar experience or can supply any information, notify the Police Department immediately.

In an effort to help stop this type of harrassment and prevent crime in our neighborhood, ITHA is sponsoring a SAFE Program and Neighborhood Watch Program at our annual meeting. We encourage our residents to know your neighbors and the phone numbers where they can be reached in case of an emergency. Be alert! If you notice anything suspicious don't hesitate to call the police 911 number. We MUST join togehter to prevent crime in our neighborhoods!

IN SEARCH OF THE ORIGINAL DEEDS....

In past newsletters we have offered the service of locating and photocopying the original deeds to homes in Ingleside Terraces. For a mere \$25 (for Association members) or \$35 (for non-members) a volunteer from our Board of Directors went to City Hall and spent several hours researching and locating each requested deed. It was a tedious project because the lot and block numbers of San Francisco county differ from the numbers in Ingleside Terraces. Since the deeds do not specify addresses, all numbers had to be cross referenced by using maps. This was extremely time consuming but, with patience, the deeds were successfully acquired.

The deeds to all the Terraces' homes are extensive and usually several pages in length. The reason for this is that the covenants of Ingleside Terraces are part of the deed itself. Can you imagine how much effort was exerted for the Association, upon creation, to set these restrictions on every lot in Ingleside Terraces? Also, in an attempt to protect the high standards and maintain the value of this neighborhood, it was set up so these covenants and conditions run with the land regardless of how many times the house has been sold. Therefore, it is always a good idea to check the deed to your lot before you build any major alteration or plan to use your house for any purpose other than a single family dwelling. We are all bound by these restrictions regardless of their age.

If you are interested in receiving a copy of your original deed simply send us a check for the correct amount along with your address and allow six to eight weeks for delivery. All funds received from this project go toward neighborhood beautification.
